TUITION CONTRACT TERMS

In consideration of Holy Trinity School, Wallingford, CT, accepting my child I hereby agree to the following conditions:

- 1. I agree to pay Holy Trinity School the tuition amount as per **the Tuition Schedule** for said child for the academic year 2025 2026 in accordance with the tuition payment plan chosen.
- 2. I understand that if I withdraw my child from Holy Trinity School:
 - a) Withdraw after June 1st two months tuition is withheld (due) to cover the cost of books and materials.
 - b) Withdraw after the first fifteen days of school the parent is responsible to fulfill the entire amount of the tuition contract.
 - c) Infractions with regard to financial status with the school, ranging from missed tuition payments, late payments, and overdue fees will result in HTS withholding school records.

- d) Rolling Admission: The tuition will be prorated for enrollments after October 1st.
- 3. **FUNDRAISING FEE \$500:** In addition to all other payments specified in this agreement, I agree to contribute to the fundraising activities of Holy Trinity School's Home School Association by selling \$1,000 worth of merchandise **PER FAMILY** from all HTS fundraisers, from which the school receives a portion of the profit. **OR** instead of the \$1,000 worth of merchandise, participate in the \$500 buy-out program **PER FAMILY** by the close of all school fundraisers. The buy-out amount will reflect a percentage of the selling amount of merchandise.

TUITION AND FEE PAYMENT OPTIONS

Student tuition is due and payable on July 1, 2025. Selection of a payment option is a financial accommodation to parents and does not relieve them of their responsibility to complete the tuition for that year. If payment PLANS B, C, or D are selected and a student withdraws from school, additional tuition payments may be required. Holy Trinity School will collect those additional payments through various procedures. All families are enrolled in FACTS for recording and tracking of tuition and fees, and **neither Holy Trinity School nor FACTS will have any other access to your bank account.** Payments may be paid by check, cash, and on FACTS on the appointed due dates according to one of the following options:

- Plan A: Payment in FULL on or before July 1, 2025. You will be billed by FACTS \$25 for an enrollment fee.
- Plan B: Parents may choose a SEMI-ANNUAL payment plan for payment beginning July 1, 2025 and January 1, 2026. You may elect to have payments be automatically deducted from your checking/savings account. You will be billed by FACTS \$25 for an enrollment fee.

• Plan C & D: Parents may choose a MONTHLY (Plan C) withdrawal plan or a QUARTERLY (Plan D) withdrawal plan. These plans begin July 1, 2025. You may elect to have payments be automatically deducted from your checking/savings account. There is an annual \$55 fee per family enrollment for these plans. This charge is applied by FACTS and will be reflected in your tuition bill.
